We use cookies and other technologies to receive and store certain information whenever you interact with us or third-parties that use our services. This information helps us recognize you, create a customized experience for you, and tailor marketing messages to your preferences. Examples of this information might include ads or articles you click on, type of browser you use, search terms, and geographic location.

Minors:

This Website and the services we provide are not intended for children under the age of 18 years. We do not intentionally collect information from minor children who are under the age of 18 years. Our website is not designed to attract children to use it, however we also

cannot prevent them from accessing the website in the same way that a parent can restrict and monitor the use of the internet by their child.

Sharing information with third-parties:

- d) If we recognize that an ad violates our terms of use or the rights of a third party; and / or
- e) If we believe there is an emergency involving personal danger.

We collect information to communicate with you:

Occasionally, we will send you information and announcements about our Website and our services. Opting out of ongoing email communication from our organization is always your choice. You can opt out by directly contacting us or through other means that we provide.

E-Commerce:

We use secure processes intended to protect user information and maintain security of data. A unique username and password are assigned to each account-holder, which is required to access their account. It is the user's responsibility to protect the security of this login information.
